## 4.2 Feed Back from the IOSH Scotland 1 Day Conference

Over a hundred delegates, presenters and exhibitors congregated at Perth Racecourse last month for the IOSH Scotland Conference.

Following a short address by current IOSH Scotland Chair Stan Brown, Martin Coyd OBE presented a session entitled 'No Cows on the Ice' an expression we finally learnt was Scandinavian in origin meaning 'there is nothing to worry about'. With regard to workplace mental health, Martin quickly showed that we are a long way from being 'No Cows on the Ice'.

Martin's session was followed by an informative but entertaining session from HSE specialist ergonomist Chris Quarrie, on the HSE's MAP and RAPP tools, a practical management skills session given by Colin Russell, on managing LEV contractors, and a café style ask the expert session.

Delegate feedback received has been very positive with the event as a whole receiving a 4.7/5 rating overall.

If you missed this event, given this feedback and the clear appetite for members in Scotland to attend an event like this organised by local members, you will be pleased to hear that IOSH Scotland expect to be able to run a 1 day conference in 2019 along the same lines as 2018 and for a similar price.
