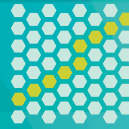


Safety, Health and Environment for Construction Workers

Delegates will be able to demonstrate understanding of the course syllabus by taking an end-of-course exam. On successful completion of the exam, delegates will receive an IOSH certificate or passport card.

Criteria

To be eligible to deliver the course, trainers must:

- have two years' construction experience OR a level 3 sector specific qualification
- be a Technical member of IOSH
- have up-to-date CPD
- have an adult training qualification at level 3 on a regulated qualifications framework OR have successfully completed the IOSH *Train the Trainer* course
- have two years' substantial face-to-face training experience.
