Where a sector-specific qualification or experience is required, we will obtain these details from your membership record.

Trainers for our senior level courses must be able to provide evidence of their experience, knowledge and training skills. They must have significant business leadership experience or a business qualification at level 5 or equivalent and this must be demonstrated in their CV.
